My Observations

- Ukrainian norm of publishing in Scopus and WoS indexed journals: Merit & Demerit
- International Journals are mostly in English, which is a disadvantage for Ukrainian authors who mostly teach/research/work in Ukrainian or Russian langaue
- Those who write originally in Ukrainian, or Russian have to pay high to English translators; half of the authors translate using Google
- Why do they translate using Google? Two reasons>
 - Translators are not effective and accurate due to technical constraints
 - Journals find high extent of errors in translated texts and they charge for corrections if their service is hired
- In a number of cases, translators do not have any fault. Original texts are inherently poor and weak. Not everybody is good in writing even in native language.
- Ukrainian authors mostly follow their own national style of writing and formatting
- Some authors are rigid and egoist, and, hence, they do not accept their errors
- Majority of authors do not learn from the mistakes and errors they made
- Illusion of Scopus indexed journals and the translators having worked there

COMMON ERRORS – group 1 General Format of Writing Research is Ignored

- Author Information
- Abstract
- Keywords
- Introduction
- Materials & Methods or Methodology
- Results
- Discussion (Result & Discussion can also be together)
- Conclusions
- Recommendations (optional)
- Figures and Tables with Captions
- Funding Source
- Author Contributions
- Conflict of Interest
- Acknowledgement (optional)
- References
- Annexures

COMMON ERRORS – group 2 Journal's Specific Guidelines & Styles are Ignored

- Demonstration of Journal Guidelines (all journals)
- Demonstration of Journal Styles (read published articles carefully): Title, Authors' info, Keywords, Headings numbered or not, Subheadings numbered or not, Table numbering, Figure numbering, References or Bibliography, Footnotes or Endnotes or Both, Deviation from standard referencing, Citations & References in number format or alphabetical order, Declarations or not, Other items

COMMON ERRORS – group 3 Ukrainian Format vs. International Format

- Abstract (e.g. A3 sample)

- Review of Literature (example below)
- Citations
- References

Shekhovtsov, M.A. Shumilo, N.M. Yarmolenko, and others. The most fundamental works that indirectly relate to the European integration are of P.V. Tyhyi "Ecological-legal regulation of special use of wildlife" (2000); V.V. Shekhovtsova "The Right of private ownership on objects of the animal world" (2009); L.V. Furmanova-Struk "Legal ensuring of Biosafety in the implementation of genetic engineering activities" (2005); L.D. Nechiporuk "Ecological-legal regulation of the rational use of wildlife" (2009).

COMMON ERRORS – group 4 Long and Undesirable Details in Abstract



- Not Long, Only Short, 100 words
- Not need to write Ukrainian version
- Context and Importance of the article
- Methodology adopted, geographical area
- Findings or Results
- Concluding point

COMMON ERRORS - group 5

Ambiguity in Introduction and Methodology

- Overlaps

- Unclear Contexts, especially in Introduction part
- Facts and figures unchecked or not supported by references
- Muddling with parts of Results
- *Methodology generally underexplained and confusing
- *Methodology in review and legal papers is full of ambiguities and theoretical explanations
- Repetition
- Scarce footnotes for unpopular terms, words, legal terms

COMMON ERRORS – group 6 Common Writing Errors in Body Text

- Long, complex, incomplete and confusing sentences
- Abbreviation first time with no expanded form
- Use of pronouns and first & second forms (I, am, we, us, our, you, your) in place of passive voice and third forms
- Incorrect punctuation for Genus and Species: *Tectona* grandis L. vs. tectona grandis. Family name can also be italic, e.g. *Rosacea*.
- Writing digits in words and words in digits
- When units are not written properly and clearly

COMMON ERRORS – group 6 Common Writing Errors in Body Text

- Use of decimal point vs. comma in numerical data
- Improper and inadequate citations and references
- New term, word, concept, legal item, vernacular item, idea not supported by explanation or elaboration in the footnote. Web source should also be given.
- If a Ukrainian word or sentence is used, its English translation should be included in bracket.
- Format for Tables, Figures, Graphs, Photos
- Punctuation errors: , :; " double space, dot,
- Uniformity issues: e.g. honor/honour, color/colour

COMMON ERRORS - group 7 Serious Mistakes in Citations

- Which referencing is adopted by journal? Harvard, APA, ACS, AAA, Chicago/Turabian, Oscolla

- Authors do not notice the Submission Instructions
- Consent / Agreement not read carefully
- Casual approach to communications
- Research Ethics & Compliance
- Errors in Authors Information (after publishing)
